**PUBLIC NOTICE FOR AUCTION OF SEIZED GOODS/ITEMS & ARTICLES**

The unclaimed seized goods/ items & articles during the course of encroachment removal action taken by General Branch / Enforcement Cell, West Zone under the provisions of DMC Act 1957, will be auctioned on 01<sup>st</sup> of July, 2026 at 11.00 A.M. at Meeting Hall situated in the Office of Dy. Commissioner, West Zone, 1st Floor, Dr. Sahib Verma Nigam Bhawan, Shivaji Enclave, Raja Garden, ND Delhi-110027. The goods/items & articles to be auctioned, can be inspected on any working day between 9 A.M. to 5 P.M. at Municipal Store, Beri Wala Bagh, with the prior permission of Admin. Officer, West Zone. The terms & Conditions of the auction will be as under:

2. Each bidder shall deposit the earnest money of Rs. 61,025/- (Sixty One Thousand Twenty Five only), which is almost 10% of minimum auction price/reserve price (which is Rs. 6,10,252/-) in the shape of Demand Draft in advance i.e. upto 3.00 P.M. of 29<sup>th</sup> of June, 2026, in favour of "Commissioner, MCD", which shall be returned / adjusted after the auction is over.

3. The minimum auction price/reserve price of the entire goods/items & articles to be auctioned in Rs. 6,10,252/- (Six Lac Ten Thousand Two Hundred Fifty Two only).

4. The highest bidder whose bid shall be accepted, shall have to deposit the entire amount (after adjusting earnest money) in the shape of Demand Draft, in favour of "Commissioner, MCD", latest by 03 PM 2<sup>nd</sup> July 2026, In the event of failure to pay said amount, the earnest money deposited by the successful bidder, shall be forfeited and the entire process of instant auction shall automatically be considered as cancelled.

5. Each bidder shall have to provide self-attested copies of PAN Card, Aadhar Card, GST/VAT Regn. Details along with the payment of earnest money, as mentioned in terms & conditions of Point No. 1 above.

6. The items will be auctioned on "AS IS WHERE IS" basis & no after claims whatsoever shall be entertained, in any case.

7. The successful bidder shall have to remove the goods/ items & articles within 10 working days after auction, failing which MCD shall not be having any responsibility for watch & ward of the goods/ items & articles, to be removed

8. The goods/ items & articles will be dismantled to scrap by the successful bidder. An affidavit in this regard shall be submitted by the successful bidder, before removing goods from the Municipal Store.


9. The Deputy Commissioner, West Zone, reserves the right to reject any or all the bids without assigning any reason, if deemed necessary or the same is in public interest.
