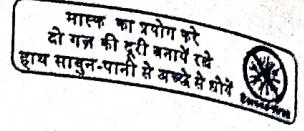

**PUBLIC NOTICE FOR AUCTION OF SEIZED VEHICLES /**  
**GOODS / ITEMS & ARTICLES**

The unclaimed seized vehicles / goods / items & articles during the course of encroachment removal actions taken by General Branch / Enforcement Cell, West Zone under the provisions of DMC Act 1957, will be auctioned on 24<sup>th</sup> of March, 2022 at 11:00 AM at Meeting Hall situated in the office of Dy. Commissioner, West Zone, 1<sup>st</sup> Floor, Dr. Sahib Singh Verma Nigam Bhawan, Shivaji Enclave, Raja Garden, New Delhi-110027. The vehicles / goods / items & articles to be auctioned, can be inspected on any working day between 11:00 AM to 04:00 PM at Municipal Store, Beri Wala Bagh, till 04:00 PM of 23<sup>rd</sup> of March, 2022, with the prior permission of Admn. Officer, West Zone. The terms & conditions of the auction will be as under :

2. Each bidder shall deposit the earnest money of Rs. 4,23,813/- (Rupees Four Lacs. Twenty Three Thousand Eight Hundred Thirteen Only), which is almost 10% of minimum auction price / reserve price (which is Rs. 42,38,126/-) in the shape of Demand Draft in advance i.e. upto 04:00 PM of 23<sup>rd</sup> of March, 2022, in favour of "Commissioner, South Delhi Municipal Corporation", which shall be returned / adjusted after the auction is over.
3. The minimum auction price / reserve price of the entire vehicles / goods / items & articles to be auctioned is Rs. 42,38,126/- (Rupees Forty Two Lacs Thirty Eight Thousand One Hundred Twenty Six Only).
4. The highest bidder whose bid shall be accepted, shall have to deposit the entire amount (after adjusting earnest money) in the shape of Demand Draft, in favour of "Commissioner, South Delhi Municipal Corporation", latest by 03:00 PM of 29<sup>th</sup> of March, 2022. In the event of failure to pay said amount, the earnest money deposited by the successful bidder, shall be forfeited and the entire process of instant auction shall automatically be considered as cancelled.
5. Each bidder shall have to provide self attested copies of PAN Card, Aadhar Card, GST / VAT Regn. details alongwith the payment of earnest money, as mentioned in terms & conditions of point no. 1 above.
6. The items will be auctioned on "AS IS WHERE IS" basis & no after claims whatsoever shall be entertained, in any case.
7. The successful bidder shall have to remove the vehicles / goods / items & articles within 10 working days after auction, failing which SDMC shall not be having any responsibility for watch & ward of the vehicles / goods / items & articles, to be removed.
