Each bidder shall deposit the earnest money of Rs. 76608/- (Rupees Seventy Six Thousand Six Hundred Eight only), which is almost 10% of minimum auction price/reserve price (which is Rs. 766080/- excluding GST) in the shape of Demand Draft in advance i.e. up to 3.00 P.M. of 26th of Sep. 2025, in favour of "Commissioner, MCD" which shall be returned / adjusted after the auction is over.
- 3. The minimum auction price/reserve price of the entire goods/items & articles to be auctioned is Rs. 766080/- (Rupees Seven Lakhs Sixty Six Thousand and Eighty Only) excluding GST.
- 4. The highest bidder whose bid shall be accepted, shall have to deposit the entire amount tafter adjusting earnest money) in the shape of Demand Draft, in favour of "Commissioner, MCD", latest by 03 P.M. on 30" Sep. 2025, In the event of failure to pay said amount, the earnest money deposited by the successful bidder, shall be forfeited and the entire process of instant auction shall automatically be considered as cancelled
