Every bidder shall have to deposit a sum of Rs, 30,000/- in the form of Demand Draft in favor of Commissioner MCD as earnest money before participating in the bid, which shall be refunded/adjusted after completing the bidding within 15<sup>th</sup> working days to the bidders except successful bidders. The highest bidder shall have to deposit the entire amount of bid in form of Demand draft including 18% GST within 24 hrs. The goods will be auctioned on "As is where is basis". The chairman of the committee shall reserve the right to cancel the bids without assigning any reason for the same. The successful bidder has to remove the goods from the store within 7 days after auction. If 13.08.2025 is declared to be holiday then auction shall be scheduled in next working day.

- 1. The date of the Auction is fixed on 13/08/2025 (Wednesday).
- 2. Auction bid will be strictly on terms on "as Is where is basis".
  - Only original bidder/owner of any firm or authorized person of bidder will be allowed to participate in the Auction.
  - Minimum bid of the auction will be Multiple of Rs.5000/-.
- 3. Intending bidder shall deposit earnest money of Rupees thirty thousand (Rs.30,000/-) in the form of bank draft (DD), failing which, no one shall be permitted to participate in the bid. The earnest money will be return or adjusted as per following condition.
  - I. Earnest money will be adjusted or the highest bidder in the final amount of the Auction.
  - Earnest money will be returned for every participated person e le except highest bidder within 15 Working days after completing the Auction process.
