Terms and conditions:

- The Maximum time period between the date of manufacturing and date of supply of drug shall not be more than $\frac{1}{4}$ of the whole self life period of such drug.

- Supply is to be arranged by the firm within 15 days from the supply order. It should be stamped Not for sale. MCD supply. If delay then penalty of 2% per week of the total cost of order value will be imposed after which order stand cancelled
- All supply will be subject to the approval of the purchase Board. Right of approval/ rejection reserved with the purchase Board. The firm has to remove the rejected part material from this hospital within three days of the intimation at its own cost.
- No firm will be eligible to withdraw after its rates are opened/ after the submission of the quotation / tender.
- In case the order is placed and firm is not in position to execute the supplies, the material will be purchased from the local market and The difference shall be deducted from any of the bills pending in MCD with approval from DHA/MCD.
- Fall clause shall apply. Any aberration shall invite suspension of future business with firm.
