Specification of the Inj. Anti-Rabies Vaccine IP (for Human Use):

- 1. Rabies Vaccine, Human I. P. should be Freeze-dried purified Vero cell Rabies/chick embryo cellsvaccine 2.5 IU inactivated rabies antigen with 1ml. diluents, 2 ml syringe with needle 24G available for intra dermal usage.
- 2. A vaccine should be in freeze dried from and should be stable between 2-8 degrees Celsius.
- 3. The vaccine should be accompanied with suitable diluents along with sterile syringe and needle for reconstitution.
- 4. The vaccine upon reconstitution with the accompanied diluents, should have volume of 1ml and should be suitable for intramuscular or intra-dermal use.
- The vaccine and the diluent should be free of any impurities or contamination.
- 6. The vaccine vial should be supplies in tamper proof packaging. The supply should be made under proper cold chain conditions.

The rate must be quoted in figures as well as in words and should be protected with transparent tape, failing which the bid shall be rejected.
