

## Terms and conditions:-

- 1. The tender /quotation should be submitted along with the required documents/certificates.
- 2. The rates quoted should be valid for a minimum period of twelve months.
- 3. The firm must provide 4 nos. of preventive services per annum and any numbers of emergency calls within 24 hours to maintain the equipment functional.
- 4. Any interested firm may visit the department to inspect the equipment and submit the quotations accordingly.
- 5. The bidder should not be blacklisted or debarred in any govt. institution/department at the time of participation.
- 6. Rates of consumables, if any should be quoted separately with the quotation.
- 7. The firm should have atleast 3 years experience of CMC of OT Lights at minimum 2 govt. hospitals.
- 8. The L-1 firm must submit PBG/FDR amounting to 3% of the total cost of CMC in favour of Medical Superintendent, Hindu Rao Hospital to be valid for 14 months.
- 9. Payment will be subject to the submission of satisfactory report by the concerned department.
- 10. No firm will be eligible to withdraw its rates after the submission of the quotation/tender.
- 11. Penalty @ 2% per week of the total cost of the order value will be imposed on the firm for not attending emergency calls subject to maximum 6%.
- 12. Multiple offers will not be accepted
- 13. Rates quoted should not be higher than rates quoted to any other Govt. Hospital/institution.
- 14. Percentage of applicable taxes must be clearly mentioned. Also it should be clearly mentioned that the quoted rates are inclusive or exclusive of taxes.
- 15. Rates should be clearly written inclusive of all discounts likely to be offered by the firm in the price bid.
