
Specific terms and conditions

1. The contract or agreement is awarded for a period of 5 weeks from the date of execution of contract.
2. The price shall be revised as per the increase/decrease in price by the state or by the central government from time to time as per quotation.
3. Rates should be inclusive of all taxes and cartage.
4. The supply of toned milk would be approx 100-120 liters which may vary according to the need and demand.
5. Requirement mentioned in the quotation form is approximate which may vary according to the need and demand.
6. The supply is to be made in 6 liters packing along with plastic crates.
7. The supply will be delivered at the hospital premises dietary department Kasturba Hospital, Near Jama Masjid, Daryaganj, New Delhi-110002, preferably time 6 AM to 3 PM or as and when required by the department.
8. Any cartage or freight charges will be borne by the agency /firm.
9. Purchaser will be Medical Superintendent Kasturba Hospital, Daryaganj, New Delhi- 110002 or any other person authorized by him/her or his/her behalf.
10. Test report of toned milk will be provided as and when required or demanded by the dietary department Kasturba Hospital.
11. The payment of the bill shall be made after completion of the weekly supply and after 15 days of submission of proper invoice. No advance payment will be considered.
12. Demand shall be informed to the supplier one day before in advance by telephonically.
13. In case of any dispute, the decision of the Medical Superintendent Kasturba Hospital, Daryaganj, New Delhi-110002 will be final.
14. In case of the said article gets rejected the said officer shall not be required to assign or give any reasons for such rejection and his/her decision shall be final and conclusive binding upon the contractor who shall immediately arrange to remove the rejected good in the specified time, failing which local purchase will be done and the excess amount incurred will be deducted from the pending bills/incoming bills.
15. The firm shall not engage any sub-agency or transfer the contract to any other person.

General Terms and Conditions:-

- a. Copy of PAN Number.
- b. Copy of GST Registration No.
- c. Should submit FSSAI license no. and copy of the same.
- d. Should provide reasonability certificate that the price is lesser than or equal to at which supplied to govt. hospital including MCD Hospitals.
- e. Should not be blacklisted.
