## Subject: Approval for calling Expression of Interest (EOI) for mechanized cleaning of footpaths.

The Corporation is taking up the work of mechanized cleaning of roads by deploying a fleet of Mechanical Road Sweeping Machines which also reduces the dependency on manual labour. However, at present the footpaths are cleaned by deploying the manual labour. In this regard a discussion was held on 12/6/2023 chaired by Commissioner, MCD and it was directed to explore the possibility of cleaning footpaths through mechanized means.

Since the concept of cleaning footpaths through mechanized means is proposed to be introduced in MCD and exact number/name of the agencies/vendors involved in this the technologies available, it would be appropriate that first agencies/vendors/technology are identified. And for that to happen, it is proposed to call an Expression of Interest (EOI) for mechanized cleaning of footpaths so that feasibility & modus can be explored in discussion with stakeholders.

The Expression of Interest (EOI) will be formulated on the basis of guidelines mentioned in Manual for Goods and Procurement (DoE) for financial credentials (i.e. turnover, net worth, liquidity etc.) and experience of executing similar work. The detailed terms and conditions required for calling EOI shall also be prepared in due course of time.

Subsequent to the outcome of Expression of Interest, the technology will be finalized and the bids will be invited. All the codal formalities including not limited to AA & ES/ other details/approvals will be sought from appropriate authority for the work accordingly.

Prior to calling EOI, for detailed discussions, acquaintance with experience of prospective bidders in the field is required for exploring the available technologies, vendors, mode being followed globally for such activities. It is therefore proposed to call a meeting by inviting public notice on MCD web portal and in leading newspaper before inviting EOI.

In view of above, the following approvals are solicited from the Competent Authority:-

- 1. In-principle approval for processing the case initially for calling Expression of Interest (EOI) for mechanized cleaning of footpaths. Prior to calling EOI, calling meeting with the prospective bidders by inviting public notice on MCD web portal as well as in leading newspaper.
