As per clause no. 25 of the NIT, the advertiser is required to submit copies of receipts/challans after statutory deduction from the salary of their employees every month. They feel that the said clause is futile as the work of operation of maintenance may be outsourced housekeeping to agencies and such agency shall be responsible for all the stator deduction, if and as applicable. In such circumstance, they see no reason for the advertiser to submit the copies of receipts/challans of its employees. However, for statutory compliance, it may be ensured by SDMC that statutory dues are paid by the advertiser and its housekeeping agency for which the advertiser shall be responsible at all times and be asked to submit undertaking to this effect every quarter. We request if the said clause is revised accordingly.
