Sub: Reply of pre-bid queries raised by the prospective bidders in respect of the NIT Nos. CO/Advtt./E-Tender-14/2023-24/D-1510, CO/Advtt./E-Tender-15/2023-24/D-1511, CO/Advtt./E-Tender-16/2023-24/D-1512, CO/Advtt./E-Tender-17/2023-24/D-1513 and CO/Advtt./E-Tender-18/2023-24/D-1514 dated 12.09.2023.

With regard to the queries/suggestions made by the prospective bidders in the subject captioned NITs, the point wise reply to the queries/suggestion raised by the prospective bidders is as below:

Sl. No.	Pre-bid query	Reply of the Department
1	That the incubation period of 15 days is very short, as there are multiple agencies involved in the installation of unipoles. Getting electricity connection within 15 days is also difficult and hence, the incubation period may please be increased to at least 30 days.	As per RFP.
2	The provision of Annexure 6 wherein display report is required to be submitted by licensee every month, may please be dealt with. The same used to be required when advertisement tax was to be paid and this has become redundant. Annexure 6 should be deleted in all the upcoming tenders and the requirement to submit this Annexure in all the previous tenders should be cancelled by way of issuing a general corrigendum. The same was accepted by the Hon'ble Commissioner, MCD in the meeting dated 19.09.2023.	As per RFP.
3	The e-tenders for many clusters should be combined and a single technical bid for all the tenders should be asked to be submitted. As of now, separate tenders for each cluster/individual unipoles are called for which becomes quite cumbersome for the participants. Separate Financial bids for different clusters/ Individual Unipoles may be called within the same tender.	As per RFP.

4	The incubation period of all designated clusters/individual unipole should be minimum 30 days in place of 15 as it takes time to obtain electricity connection, repairing works and erected of designated clusters/Individual unipoles.	As per RFP.
5	The contractors with erstwhile EDMC having outstanding only on account of dues of the period of Covid Lock – down may be permitted to participate in the E-tender as the Force Majeure relief during the Covid lock down is under consideration by the Competent Authority of MCD.	The contractors having outstanding dues, only on account of the period of Covid lock – down, are permitted /allowed to be qualified in tender, subject to the undertaking that the firm/contractor shall clear the said dues once the decision in the matter is conveyed by the Department.
6	As per Annexure – 11 wherein para a and b should be Net Worth as on 31.03.2023 in place of 31.03.2022 and Profit & Loss statement, Financial Turnover, Audited Balance Sheet & Income Tax Returns up should be 2022-23 in place of 2021-2022.	As per RFP.
7	The contractors with erstwhile EDMC having outstanding only on account of dues of the period of Covid Lock –down may be permitted to participate in the E Tender as the Force Majeure relief during the Covid Lock Down is under consideration by the competent authority of MCD.	The contractors having outstanding dues, only on account of the period of Covid lock – down, are permitted /allowed to be qualified in tender, subject to the undertaking that the firm/contractor shall clear the said dues once the decision in the matter is conveyed by the Department.
