Puram, Sector-13, New Delhi-110066 vide o.o. no/Misil No.6-76/CGHS/Gr. Cell/2024/(E office-8295838) 1284-1308. dated 27.11.2024. However The above matter to be investigated by the High-Level Committee of CGHS. Final revocation/de-empanelment will follow as per the recommendation of High Level Committee of CGHS.

In view of the above the empanelment of said hospital is also temporarily revoked in r/o beneficiaries of MCD w.e.f. 27.11.2024 with same terms and condition of the existing policy of MCD. The final revocation/de-empanelment from MCD shall depend on the outcome of the investigation by the High Level Committee of CGHS in this regard.
