SOP for Enlistment of makes of Electrical items as preferred makes in MCD

1. This standard operating procedure is for inclusion of various makes/ brands in the list of preferred make for Electrical/E&M/Auto works in MCD.
2. Only OEM/Manufacturers can apply for inclusion of makes/Brands
3. Applications duly numbered serially (preferably spiral bound) , signed and stamped by authorized signatory should be submitted physically/ by post/courier to the

Executive Engineer (Elect)/Planning, Room No.7, Ambedkar stadium, Delhi Gate, New Delhi- 110002.

4. A committee comprising the following members shall be constituted for evaluation of the application and documents :-
 - SE(Elect)/Planning - Chairman
 - EE(Elect/E&M/Auto)/Planning - Member
 - EE(Elect/E&M/Auto)/QC - Member
 - AE(Elect/E&M/Auto)/Planning - Member secretary
5. The above committee shall evaluate the application and give its recommendation to the competent authority i.e. Chief Engineer (Elect)/Planning.
6. Department may seek clarifications/shortfalls on the submitted documents, if required, within two weeks preferably and communicate the same to applicant by e-mail with a request to furnish required clarifications with or without supporting documents within two week's time, failing which it will be presumed that they do not have any further clarifications to furnish and decision on application will be taken accordingly.
7. MCD reserves the right to inspect the work place / factory / manufacturing unit for the verification of manufacturing and testing facilities declared by the OEM/Manufacturer and product quality purpose. Manufacturers/ OEM shall arrange inspection of the product as and when required by the MCD.

A. Minimum Eligibility Criteria

1. **Grouping** – The products being used in MCD which are to be considered for enlistment have been classified in Groups (refer Annexure-A) based on the Scale of Manufacturing facilities or turnover required for different type of products. The eligibility of the OEM/Manufacturer shall be evaluated based on the same.

2. **Turnover-** Shall have average financial turnover in the last three financial years continuously duly supported with certificate by Chartered Accountant as per the following (Annexure –IV):

Minimum Average Turnover:

S. No.	Group of Item	For OEMs/Manufacturers other than MSME	For MSME OEMs/Manufacturers
1	For Group "A" items	100 (Hundred)Crore	20 (Twenty) Crore
2	For Group "B" items	50 (Fifty) Crore.	3 (Three) Crore
3	For Group "C" items	10 (Ten) Crore	No Limit

3. **Marking Criteria:-** The application of OEM/Manufacturer will be evaluated as per the marking System mentioned in Section-C of this document. The OEM/Manufacturer has to score "40" marks out of total 60 marks to get qualified for recommended list of preferred make
4. Manufacturers shall submit Chartered Accountant certificate with UDIN of average annual financial turnover certificate and profit/ loss detail for the last three audited financial years.
5. Manufacturers showing continuous losses (profit after tax shall be positive) during the last three audited financial years shall be summarily rejected.
6. OEMs /Manufacturers claiming MSME status shall submit valid MSME certificate.
7. Undertaking as OEM / Manufacturer that their company and any of their items / products have not been blacklisted by Central Govt. / State Govt. / PSUs. (As per Annexure- II)
8. Undertaking from OEMs/ Manufacturers shall be submitted in respect of manufacturing the product in their factory/OEM outsourced facility for the product to be enlisted.(Annexure-III)

B. EVALUATION CRITERIA & DOCUMENTS REQUIRED:

- (i) **Product / Item Production Record and Item / Product Certification Status –**
- (a) The number of years for which the applicant firm has been undertaking production of Item / Product to be enlisted, as an indication of its stability, OEM/manufacturer is required to submit documents such as Completion Certificate/ Order/MSME certificate/Factory License /Udyam / NSIC/ Third party Test certificates. – ref. Annexure –V.
- (b) OEM/manufacturer is required to submit the certification of the product complying the IS / International standard of the manufacturing. (Test certificate of product from approved Government / Private laboratories in conformity with relevant IS code/International Code) For High Mast wind test from any govt. institute shall be considered as product certification) – ref. Annexure –V.
- (ii) **Testing Facility –** Type of testing facility at the manufacturing unit available to establish

the quality of the product / item, OEM/manufacture is required to submit documents such as Certificate/Self Declaration-ref. Annexure-VI.

(iii) **Experience Details-**

OEM / manufacturer should have successfully completed work / supply of minimum cumulative order of following value during last seven years from the date of application for the item to be enlisted (as per Annexure VII).

1. For Group "A" items: Rs. 10.0 Cr. (excl. GST /VAT)
2. For Group "B" items: Rs. 5.0 Cr. (excl. GST/VAT)
3. For Group "C" items: Rs. 1.0 Cr. (excl. GST/VAT)

a. In case of supply/SITC in any Govt. / CPSUs /SPSUs	• Purchase Order & Completion certificate issued by any Govt. Official. • Consignee Receipt & Acceptance Certificate (CRAC) issued by GeM. • Direct PO issued by the Govt./ CPSU/ Railway/ DMRC and Tax Invoices with Consignee/ Billing to Govt./ CPSU/ Railway/DMRC • Work done by the Contractor for the Govt./ CPSU/ Railway/ DMRC and completion certificate issued by the contractor mentioning Govt./ CPSU/ Railway/ DMRC project details along with tax invoice indicating consignee as Govt./ CPSU/ Railway/ DMRC. • PO from Contractor for the Govt./ CPSU/ Railway/ DMRC work along with Inspection Report/ Packing details/ Delivery Challan duly signed and stamped by the Govt./ CPSU/ Railway/ DMRC officials
b. In case of SITC in any Non-Govt.Organization	• Purchase Order, Invoice copy along with TDS certificate along with a certificate issued by registered Chartered Accountant with UDIN, clearly specifying the name of work, total payment received against the work order /purchase order and TDS amount for the work completed.
c. In case of Supply in any Non-Govt. Organization	• Purchase Order, Invoice copy along with proof of payment receipt such as bank statement along with a certificate issued by registered Chartered Accountant, clearly specifying the name of work, total payment received against the work order /purchase order.

Note- For the lower capacity items; the experience of higher capacity item (if applied) is considered. Viz. UPS, transformer etc.

- (iv) **Approval Status** –OEM/manufacture is required to submit approval letters from Govt. / CPSU's/ SPSUs (within last 03 years from date of application) with validity or tender specific approval with date of tender (within last 03 years from date of application). Annexure – VIII.
- (v) **Service Network Supports/ Dealership Network-** OEM/ Manufacturers are required to submit self-declaration with supporting documents to show their presence service/dealership network availability in Delhi NCR in support of after sales service. Ref. Annexure – IX.

Note-

1. After this process, brand of items as enlisted shall be indicative only.
2. The enlistment of make shall be done for a period of 3 years provisionally. Fresh application along with documents has to be submitted by the OEM/Manufacturer for renewal /extension atleast 3 months before expiry of validity.
3. Mere inclusion of brand name in the preferred make list does not guarantee for use in work unless specification of brand meets technical specifications of product as stipulated in tender document.
4. The OEM/Manufacturer will be required to provide items as per the specifications indicated in tender document.
5. MCD reserves full rights to remove or include any of the item /Products as listed in Annexure-A at any time without assigning any reason, whatsoever.
6. Enlistment can be withdrawn any time on reporting of unsatisfactory/poor performance from field stations.
7. MCD reserves the full rights to cancel the procedure at any time without assigning any reason, whatsoever.

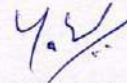

D. REJECTION OF APPLICATION

- (i) MCD reserves the right to reject all the application or any of the application without assigning any reason.
- (ii) MCD also reserves the right at its sole discretion not to enlist any item/product under this application. MCD shall not pay any costs or loss incurred by the agencies in the preparation and submission of any requisite application for any of the items described herein.
- (iii) The application of OEMs/ Manufacturers who don't have required minimum turnover as mentioned above shall be summarily rejected.
- (iv) If the OEM / Manufacturer deliberately gives wrong information or suppress any information in his application, MCD reserves the right to reject such application at any stage or to delist the products/items, if enlisted, in addition to any other appropriate/legal action.

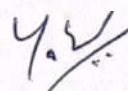
