

In compliance of judgment dated 19.12.2014 of Hon'ble High Court of Delhi in WP (C) No. 5356/2014, titled as "K.C. Meena Vs. Commissioner, North DMC & Ors." read with Contempt petition No. 112/2014 in O.A. No. 4125/2012 titled as "Ravinder Singh Vs P.K. Gupta and Others" a DPC was held in the UPSC on 26.12.2016 to the post of Executive Engineer (Civil). The recommendations of said DPC as contained in the Commission's letter No. F.1/30(11)/2016-AP.1 dated 28.12.2016 has been notified after approval of Competent Authority vide office order No. F.8(8)/CED(NDMC)/Pt.VII/2015/GF-02/98 dated 12.01.2017.


