In view of the above the empanelment of said hospital vide MCD circular No. 434/DHA/MCD/2024 dated 15.02.2024 & MCD circular No. 164/DHA/MCD/2024 dt.28.08.24 also stands suspended in r/o beneficiaries of MCD as per terms of agreement, till said suspension is revoked by CGHS.

However, the MCD beneficiaries already admitted in the above tabulated 06 Hospital prior to 11.11.2024 shall continue to be provided treatment at CHGS Rates till completion of their treatment and their bills are to be submitted as usual with justification for consideration and payment.
