3. EARNEST MONEY DEPOSIT

1. Bidders shall submit an EMD of INR 3,00,000 (Rupees three Lakh only) online through specified mode on www.tenderwizard.com/SOUTHDMCETENDER, along with their Bids. In case of unsuccessful bidder, earnest money/bid security will be refunded to the unsuccessful bidder without any accrued interest within 60 days from date of notification of the award of contract.

- 2. Following categories are eligible for exemption from furnishing Earnest Money Deposit (EMD) and cost of tender/bid document for online bidding in relaxation of the Prequalification Criteria (PQC):
 - i. Micro and Small Enterprises who are manufacturer of the primary product category or Service provider of the Primary Product category and give specific confirmation to this effect at the time of bid submission and whose credentials are validated online through Udyog Aadhaar and through uploaded supporting documents. (Note:- MSME NIC 5 digit code 95111- Repair and maintenance of Computer and peripheral equipment, is valid for exemption from Earnest Money Deposit (EMD) and tender cost/bid processing fee).

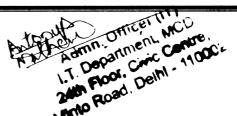
4. FORFEITURE OF EMD

EMD shall be forfeited if,

- a) The bid is revoked during its validity period.
- b) The bidder indulges himself in any undesirable practice or malpractice at any time, which would include the instance of a bidder after submission of tender and during the tender validity period resilient from his offer or modifies the terms and conditions thereof (in a manner not acceptable to IT department, South DMC).
- c) The successful vendor does not convey his written acceptance within a maximum period of 15 days of the order placed on him by IT Department South DMC.
- d) The successful bidder does not deposit the security Deposit within the stipulated period, the successful bidder fails to start the work within the reasonable period or fails to show reasonable progress in execution of the work/contract.

5. SCOPE OF WORK

1. The AMC rates mentioned in this contract will be valid for one year from the date of awarding the contract. No demand for revision of rate on any account shall be entertained during the contract period. The AMC can be extended, purely at the discretion of SDMC, based on the performance of the vendor, on same prices and terms and conditions for a further period of one year.



- 2. The AMC rates for data center Infrastructure such as UPSs, Air Conditions, Safety and security systems, network infrastructure (passive components) etc., the bidder shall quote in fixed price and before quoting the price, bidder should survey the Data Center Infrastructure for which AMC is required. Details of UPSs, Air Conditions, Safety and Security Systems, etc. are given at **Annexure-A**.
- 3. Network Infrastructure (passive components) include:
 - a) Patch/Jack Panel.
 - b) Patch cords CAT 6 used between patch panel and switch, cable managers and all related hardware's.
 - c) LIU
 - d) Fiber Cables and fiber patch cords.
 - e) Data center racks for servers & Networking Equipment's.
- 4. The system maintenance charges for UPS, batteries, Air Conditioning consumables items shall include Lamps, FM200 Gas, AC Refrigeration Gas, AC Filters, UPS Batteries etc.
- 5. The SDMC will keep a record of machine failure including the name of failure, date and time of booking the complaint and when the machine is set right and total down time. The records will be signed by the Company's Service engineer and SDMC representative. One Engineer needs to be deployed on all working days during office hours at the premises of the SDMC.
- 6. The service engineers would take up any reported fault within one hour. As far as possible, the repairs would be carried out on-site itself. Whenever the system cannot be repaired on site within the specified time limits, the Vendor will have the option to take the equipment to their workshop / premises with prior permission from SDMC and provide the alternative equipment of same or better specifications. The SDMC's equipment in any case will have to be repaired/set right within 3 days and returned to the SDMC. The firm will arrange their own transport, for which no extra payment will be made.
- 7. For preventive maintenance checks of each system under AMC will have to be carried out by the firm on a quarterly basis and will have to be certified by SDMC representative. A preventive Maintenance Report from the user would be submitted to SDMC, failure of this, will lead to deduction from the payments.
- 8. AMC includes OS installations, replacement of damaged items/parts, onsite maintenance and repair and other related activities. Sufficient number of spares for the systems shall be available with the firms for the proper maintenance of the system within 24 hours.
- 9. The firm will check all the Data Center equipment's under AMC along with SDMC representative before 10th of each month and submit a report.

- 10. The upgraded items (Memory, HDD etc.) purchased by the SDMC and upgraded into the existing systems/machines will also be included in AMC with the firm as soon as warranty period expires. This will be done through Addendum signed by the SDMC.
- 11. In case of intermittent failures and repetitive problems due to improper diagnosis or repair, the system will be treated as continuously down.
- 12. The equipment will be returned in good working condition to the SDMC. In case the Vendor fails to return the machine back in working condition to the SDMC, it will have to pay the contemporary price prevailing in the market of the same model and make. The SDMC shall have full liberty to deduct such amount from the pending/ensuing bills or the Performance Security Deposit.
- 13. To monitor the maintenance activity and to discuss other related matters, a monthly meeting between the SDMC and representatives of the Company may be held in the SDMC.
- 14. The personnel deployed by the Vendor shall comply with all the data security and security regulations in the SDMC. Any breach of this condition will render the entire contract as null and void and penal action including forfeiture of the Performance Bank Guarantee.
- 15. In the entire period of Contract, the vendor should adhere to the Information Technology (Reasonable Security practice and Procedures and sensitive personal data of information) Rules, 2011.
- 16. The engineer/technician deputed for preventive maintenance and rectification shall report to SDMC; carry out all the activities under the control and technical supervision of the in-charge of the SDMC.
- 17. Service for all data center equipments (server, storage, kvm switches, juniper switches/firewalls, load balancer, cisco switches, cisco routers, cisco san switches, ups, air conditioning, safety and security systems, network infrastructure (passive components) and other peripherals-Maximum acceptable downtime will be 04 hours from the time of registration of the complaint. The maximum response time of any complaints shall be two hours and the maximum resolution time shall be four hours. The support shall be provided 24x7. In case the Vendor fails to adhere to the downtime stipulated herein, penalty clause as detailed in Para 7 below will apply.

6 PERFORMANCE GUARANTEE

A Performance Security Deposit of 10% of the total value of the AMC contract shall be deposited by the successful bidder within 15 days of

accepting the contract, in the form of a Bank Draft / Performance Bank Guarantee valid for a period of fourteen months i.e. upto two months after completion of contract period in favour of Commissioner, SDMC. This will be refunded on successful completion of the contract to the entire satisfaction of SDMC. In case of any default, the total amount or part thereof will be forfeited.

7. PENALTY

- (i) Penalty for not attending to the calls as per Para 17 of Service Assurance will be Rs. 500/- per day for each data centre equipment.
- (ii) Penalty for failure of doing Scheduled Preventive Maintenance (PM) and submission of Reports in time will be Rs. 175/- per machine per day.

8. EVALUATION CRITERIA

A. Technical bid evaluation:

- i. The bidders' Technical bid Proposal shall be evaluated as per the criterion specified in the RFP.

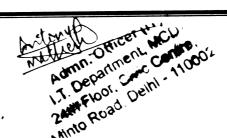
