S. No.	QUERY	REPLY
1.	Whether the MSME certified/registered company will be allowed EMD exemption for participating in the tender?	There is no exemption from submission of EMD for any bidder.
2.	Whether Technical Bid & Financial Bids can be submitted manually or not?	The Technical Bids and Financial Bids must be submitted online only.
3.	Whether the Joint Ventures of Firms is allowed in this tender or not?	No. The bidder should be an Indian Manufacturer OR its Authorized Dealer OR Distributor OR Service Provider / Centre of Children Play Equipments / Apparatus.
4.	Whether the experience of Open Gym Works will also be considered as similar work for eligibility & participation in the tender?	Similar nature of work for this tender is as per works to be taken up on award of Rate Contracts, so in this tender the Completed similar work/s means the work of Supply/Installation of Children Play Equipments / Apparatus.
5.	Copy of Solvency Certificate is allowed in bidding or not?	The bidders may submit Solvency certificate for this tender in original for an equal / more amount of Rs.200.00 Lacs from a Nationalised/ Scheduled bank in India. OR Bidders may submit Banker's Certificate for a minimum amount equal to Rs.200.00 lacs or more from a Commercial Bank in India in the prescribed format (enclosed). OR Bidder may submit Net-worth certificate equal to Rs.50.00 Lacs or more, issued by certified Chartered Accountant with UDIN, in place of above Banker's Certificate in the prescribed format (enclosed). Scanned copy be uploaded with technical bid and original of Solvency / Banker Certificate must be submitted in the office of Dy. Director (Hort.) HQ-II at 16 <sup>th</sup> Floor E-1 Block S.P.M. Civic centre New Delhi-110002.
6.	As the L-1 bidder will be considered for award of Rate Contract for Rs.2.00 Crores, so the eligibility of experience amount be considered according to Rs.2.00 crores for participation?	The eligibility of experience is for award of total R.C. of Rs.500.00 Lacs, so the participating bidders should have experience of successfully executing similar nature of works costing above Rs.200.00 lacs(minimum three works) OR work above Rs.300.00 Lacs (minimum two works) OR work above Rs.400.00 lacs (minimum one work) & detail given in tender document.
7.	How much turnover is mandatory for this tender?	Minimum Average annual financial turnover of the bidder should be at least Rs.250.00 Lacs or more during any of previous three financial years out of the last five (05) consecutive financial years. The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five consecutive balance sheet.
