Procurement of 21000 vials of Anti Rabies Vaccine 1 ml (with diluent) for the ARV centers of MCD under administrative control of Addl. DHA (Primary Health), through E-procurement on Central Public Procurement Portal.

- 2. Bid value: Rs.63,21,000/-
- Online bids on Central Public Procurement Portal (technical bid and financial bid) are invited from manufacturer/authorised distributor/authorised stockist only by the Addl. DHA (Primary Health) on behalf of the Commissioner, Municipal Corporation of Delhi, for supply of Injection Anti-rabies Vaccine 1ml Amp. (with diluent) for various Anti Rabies Centres under Administrative control of Addl. DHA (Primary Health).

The entire process of tendering will be done through e-tendering. The bidder is responsible for registration on the E-procurement portal i.e. https://etender.gov.in/at their own cost. The bidders are advised to go through the e-procurement guidelines and instructions, as provided on the e-procurement website. The Prescribed tender forms along with terms and conditions & inventory can be downloaded from e-Tendering portal i.e. https://etender.gov.in/eprocure/app and from link on tender section of MCD website i.e. https://etender.gov.in/eprocure/app and from link on tender section of MCD website i.e. https://mcdonline.nic.in free of cost. The entire tender process will be as per standard e-tendering norms of MCD. Any other information regarding tender can be obtained from office of C.M.O (CMS), MCD, E – Block, 18th Floor, Dr SPM Civic Centre, J L N Marg, New Delhi – 110002.

Tenders will be accepted under two bid system i.e. Techno-commercial bid & Financial bid.

- 4. <u>Techno-Commercial Bid. (The entire Techno-Commercial Bid should be uploaded on the etendering site as per the Tender document).</u>
 - a) As a part of initiative in e-governance, MCD has introduced e-tendering. Firms desirous of participating in e-tendering should have a valid class 3 Digital Signature Certificate (DSC). In case any firm desirous of participating in the tender does not have valid DSC, they must obtain Class 3 DSC themselves.
 - b) The Techno-Commercial Bid shall include:

- (i) CA certified annual turnover @ 50% of bid value i.e. Rs. 32 Lakhs.
- (ii) Experience for supply of similar products in the previous 3 years either of the 3 has to be provided.
 - One work order of 80% bid value.
 - Two work orders of 50% bid value.
 - Three work orders of 40% bid value.
- (iii) Authorization certificate from manufacturer in case of authorised Distributor/Stockist.
- (iv) Copy of GSTIN Registration Certificate.
- (v) Forwarding letter on letter head of the firm that all terms and conditions of bid are acceptable.
- (vi) Undertaking that the firm has not been blacklisted/debarred from anywhere and No CBI/Vigilance enquiry pending against the firm. (As per Annexure – I)
- (vii) Copy of PAN.
- (viii) Full specification of quoted item with make and model. (Brochure etc.)
- (ix) Copy of valid Drug License.
- (x) Undertaking that the quoted rates are reasonable and justified and same as being charged by them from other Govt. Institutions/hospitals.
- (xi) Declaration regarding GST, whether quoted rates are inclusive or exclusive of GST. Percentage of applicable GST must be clearly mentioned against the HSN code.
- (xii) The samples of the quoted items should be submitted at Central Medial Store located in the basement of PSMS Hospital Kalkaji on or before the closing date of the instant tender.

5. Financial Bid: (Financial bid shall not be submitted manually otherwise the bid shall be summarily rejected).

- a. The entire **financial bid shall only be uploaded online as per template** (Annexure II) given in the tender.
- b. All prices should be quoted in Indian rupees.
- c. All prices shall be quoted inclusive of charges i.e. delivery of services (FOR) at the Central Medical Store located in the basement of PSMS Hospital Kalkaji.
- d. Base Prices shall remain firm, and no increase will be allowed during the entire period of contract. Conditional offers will not be accepted.
- e. GST Rates will be applicable as per prevailing rate at the time of procurement.

6. Opening of technical bid:

The technical bid will be opened first, and tenders will be evaluated on the basis of the pre-determined evaluation criteria listed at Para 4 (b) above. The uploaded price bids of technically approved tenderers will only be opened. The comparative statement will be prepared on basis of the base price exclusive of applicable GST and the L1 (Lowest quoted rate) will be auto identified.

9. Terms and Conditions:-

- a) The item would be purchased from the manufacturer/Authorized Distributor/Authorized Stock list only. The documentary proof of the proper authorization should be enclosed with the technical bid.
- b) Online EMD payable in favour of Commissioner MCD.
- c) The maximum time period between the date of manufacturing and date of supply of drug shall not be more than ¼ of the whole life period of such drug.
- d) All supplies should be accompanied by a test report from Govt. approved analytical lab. Test report preferable should be submitted in original before the approval board, wherever possible. Multinational firms, who possess well equipped lab approved by state Drug Authority /F.D.A can submit In-house analytical test reports subject to submission an undertaking declaring that their lab is approved by State Drug Authority/FDA. However, acceptance of such test report shall be at sole discretion of the approval board.
- e) The tenderer should not be blacklisted or debarred in any govt. institution/department. (Self- undertaking to be given).
- f) Full specification of quoted item should be given in technical bid with make and model (Brochure etc.)
- g) Supply shall have to be arranged by the firm in 45 days for local items(s) and 90 days for imported item(s).
- h) All supplies/work will be subject to the approval of board and can be rejected without assigning any reason. Supplier will have to remove rejected supply within three days of intimation at own cost.
- No firm will be eligible to withdraw its rates after the submission of the quotation/tender otherwise, EMD will be forfeited.
- j) Penalty @2% per week of the total cost of the order value will be imposed on the firm in case of late supply subject to maximum 6% for 21 days from the date of supply order.
- k) Rates should be clearly written inclusive of all discounts likely to be offered by the firm in the price bid.
- Rate quoted should be FOR. Supply will be received at the Central Medical Store located in the basement of PSMS Hospital Kalkaji.
- m) Payment will be made by bill system after receiving the supply and approval.
- n) No tender will be accepted without earnest money.
- No previous earnest money will be adjusted.
- p) Multiple offers will not be accepted.
