Walk-in-Interview for filling up the post of Senior Residents & Junior Residents in Rajan Babu Institute for Pulmonary Medicine & Tuberculosis (RBIPMT & MVID Hospital).

A walk in interview will be conducted for recruitment of Senior Residents (SR) & Junior Residents (JR) on 26/02/2026 from 9:30am onwards in office of the DHA (HQ) Civic Center New Delhi . Registration for the same will done between 9:30am to 11:00 am on 26/02/2026.

All eligible candidates desirous of attending the interview must report to office of Director/RBIPMT along with the original and attested copies of the documents listed in the notice. The eligibility will be as per standard norms including for age.

Engagement will be for period of one year initially, extendable by one year at a time up to total of three years. Extension is subject to satisfactory work and conduct report.	The JR will be appointed for a period of 6 months, extendable further for six months (total of one year). Extension is subject to satisfactory work and conduct report.

Tenure of Residency :

<p>a) Total tenure of Senior Residency will not normally exceed three years including the period served in other Govt. Hospitals.</p> <p>b) In case enough candidates are not available as per (a) above, then the candidates who have completed 3 years of senior residency but are willing to serve as Senior Residents will be allowed to appear in the interview. A separate list of such candidates will be prepared and this list will be considered after list of fresh candidate as per (a) above is exhausted. However total tenure of Senior Residency will not exceed five years including the period served in other Govt. Hospitals.</p>	<p>a) Total tenure of Junior Residency will not normally exceed one year including the period served in other Govt. Hospitals.</p> <p>b) In case enough candidates are not available as per (a) above, then the candidates who have completed one year of junior residency but are willing to serve as Junior Residents will be allowed to appear in the interview. NB:

It is clarified that aforesaid provision (b) made in relaxation of the provisions of the Residency Scheme are only enabling provisions. In the first place the recruitments have to be made strictly as per the Residency Scheme as circulated by the Ministry of Health & Family welfare: vide GOI OM No. 11014/3/91-ME(P) dated 05-06-1992).

Age Limit:

Senior Resident:

Not exceeding 45 years as on last day of submission of application (Relaxable by five years in case of ST/SC candidates, by three years in case of OBC candidates and by Ten years in case of PwD candidates.

Junior Resident:

Not exceeding 40 years as on last day of submission of application. (Relaxable by five years in case of ST/SC candidates, by three years in case of OBC candidates and by Ten years in case of PwD candidates.

Terms & Conditions for Appointment :

- I. Joining shall be subject to medical fitness and verification of certificates of educational qualification/caste/age/DMC registration and internship completion certificate.
- II. For candidate applying for OBC category, the certificate must be issued by competent authority of Govt. of India.
- III. The terms & conditions shall be governed by Residency Scheme (Ref. No. GOI OM No. 11014/3/91-ME (P) Govt. of India, Ministry of Health and Family Welfare dated 05.06.1992 and amendments, if any.

- IV. No TA/DA will be paid for appearing in Interview.
- V. No private practice whatsoever shall be allowed during residency.
- VI. The tenure can be terminated at any time without assigning any reason.
- VII. Inter-Hospital/ inter-institutional duties shall normally be not permitted.
- VIII. The Director/RBIPMT reserves the right to assign any duty as and when required. No extra allowance will be admissible in case of such assignment.
- IX. The residency shall not bestow any claim or right with the incumbent for regular appointment to any post.

N.B.:

1. Incomplete application will not be considered and summarily rejected
2. 4% of seats are reserved for PwD Candidates as per the Policy of Government of India.
3. 10% of seats Category are reserved for EWS (Economically Weaker Sections) Candidates. EWS certificate shall have to be issued from appropriate Govt.
4. The Chairman of the Interview Board reserves the right to consider or reject any of the application.

Fee payable by the appearing candidate:

Rs. 1000/- for General/OBC/EWS candidates & Rs. 500/- for SC/ST candidates, payable in the form of Demand Draft (non-refundable) in favour of Commissioner MCD Delhi. The PwD candidates are exempted.

Required documents:

1. Duly filled application form.
2. 01 Passport size photograph.
3. Matriculation and Senior Secondary Certificate.
4. MBBS degree (for Junior Residency).
5. MBBS degree + PG Degree/DNB/Diploma (for Senior Residency).
6. Mark Sheets of professional examinations.
7. Score card/Sheet of FMGE (Foreign medical Graduate Examination) conducted by NBEMS (National Board of Examinations in Medical Sciences) for Foreign Graduates.
8. Internship completion certificate.
9. SC/ST/OBC/EWS certificate, if claimed. SC/ST, OBC & EWS certificate shall have to be issued from appropriate Govt.
10. Copies of experience certificate, if any.
11. Residence proof.
12. DMC registration certificate.

The candidate shall bring all original documents and submit 01 self attested set of such documents.
