- 1. In case of Senior Residents appointment will be for 89 days or till such time regular appointment against the vacant post is made, whichever is earlier.
- 2. For Junior Residents initial engagement will be for 6 month extendable up to maximum of 1 year subject to satisfactory work and conduct.
- 3. Extension is subject to satisfactory work and conduct report.
- 4. Appointment will be subject to medical fitness and verification of certificate of educational qualification/Caste certificate/DMC registration and internship completion certificate.
- 5. For candidate applying for OBC category the certificate must be issued by competent authority of GNCT of Delhi.
- 6. The service will be governed under Residency Scheme Ref No S 11014/3/91ME(P) Govt. of India. Ministry of Health and Family Welfare dated 05.06.1992 (29C-42C) and amendment thereafter)
- 7. No TA/DA will be paid for appearing for interview
- 8. No private practice what so ever will be allowed.
- 9. In case of SRs, during the first year of appointment service is liable to be terminated at any time without assigning any reason
- 10. Other service conditions will be applicable as per service condition prescribed from time to time by Government of India.

- 5. In case SC/ST/OBC & EWS candidates are not available for the post of SR/JR the post shall be filled for 44 days on contract basis from unreserved category candidates. In case suitable candidate is found in future, this appointment shall be terminated immediately.
