Education & Qualification	i. MBBS Degree from MCI / NMC Recognized University/Institution. ii. Candidate must have completed one year Rotatory Internship before date of joining. iii. The internship should have been completed not earlier than two years before last date of application.
Duration of residency	The JR will be appointed for a period of 6 month, extendable further for six months (total of one year). Extension is subject to satisfactory work and conduct report
Tenure	I. Total tenure of Junior Residency will not normally exceed one year including the period served in other Govt. Hospital. II. In case enough candidates are not available as per (i) above, then the candidates who have completed one year of Junior Residency but are willing to serve as Junior Residents will be allowed to appear in the interview.
