1. **Age limit** :- As on date of Interview.

For Senior Resident

- Gen. & EWS- 45 Year.
- SC/ST-50 Year.
- OBC-48 Year.
- Additional 10 Year age relaxation for PwD Candidates.

2. **Education & Qualification:**

For Senior Resident

- MBBS Degree from a Recognized University/ Institutions.
- PG degree/DNB/Diploma or equivalent in concerned Specialty from a recognized University/ Institute registered with Delhi Medical Council (If adequate candidate of above qualification not available specialty, those with MBBS Degree with at least 2 years experience in a recognized 100 Bedded Hospital, out of which 01 Year in concerned specialty can be considered).
- Has not completed 03 Years of Senior Residency in any other hospital.

3. **Duration of Residency**

For Senior Residents

Tenure of SR for 89 days initially to be extendable up to 03 Years after 1 day break (**Under exceptional circumstances tenure may be further extended, if vacancy is not filled up**). Extension is subject to satisfactory work and conduct report.

- If adequate number of fresh candidate who have not yet completed three years of residency.
- Available in any particular speciality those candidates who have already completed 3 Year Senior Residency will be considered.
- Separate merit list for fresh candidates from those who have already completed 3 Years senior residency would be prepared Firstly the list containing the name of fresh candidate would be exhausted for appointment and the second list would be used only after that. Only 44 Days contract will be offered to 2nd list.
- In case No Eligible candidate available for reserved seats, only 44 Days contract will be given to candidate from other category.
- In case No Eligible candidate available for reserved seats, only 44 Days contract will be given to candidate from other category.

7. **Delhi Medical Council Registration:-** Candidate must have valid DMC Registration Certificate of MBBS (Delhi) along with Registration of their PG degree/Diploma with DMC.

GENERAL TERMS AND CONDITIONS

1. Tenure: Initially for a period of 89 Days/44 Days or till the posts are filled up on regular basis whichever is earlier.
2. Extension is subject to satisfactory work and conduct report.
3. Appointment will be verification of certificate of educational qualification/caste/age/DMC registration and Internship Completion Certificate.
4. For Candidate applying for OBC category the certificate must be issued by competent authority of GNCT of Delhi.
5. The service will be governed under Residency Scheme (Ref No./S. 11014/3/91ME(P) Govt. of India. Ministry of Health and Family Welfare dated 05.06.1992 (29C-42C) and amendment thereafter).
6. No TA/DA will be paid for appearing for interview.
7. No private practice what so ever will be allowed.
8. During the first year of appointment, service is liable to be terminated at any time without assigning any reason.
9. Other Service conditions will be applicable as per service conditions prescribed from time to time by Government of India.
10. Inter hospital/Inter Institutional transfer shall not be permitted without permission of competent authority.
11. The Appointing authority reserves right to assign any duty as and when required. No extra allowance will be admissible in case of such assignment.
12. The engagement will not bestow any claim or right with the incumbent for regular appointment to the post.
