Sub:- Revision of booking rates of AC Community Halls of SDMC.

The following booking charges of AC Community Halls of SDMC are revised as under:-

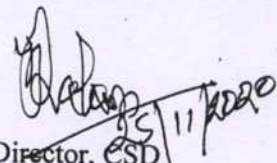

The security amount Rs. 15,000/- per booking, sanitation charges Rs. 1500/- per day and T.L.F. Rs. 500/- + GST per booking will also be applicable in aforesaid Community Halls.

The AC facility will be optional. The booking parties will have to arrange DG Set of 750 KVA capacity for the supply of electricity to the AC Units at their own cost.

The above revised rates of booking of Community Halls will be applicable with immediate effect. It is also clarified that the revised rates of booking for Community Halls will have prospective effect and will not be applicable for the bookings already made. However, DG Sets will be provided to those booking parties who have already booked the Community Halls in Dwarka area prior to this order.
