**Sub:- Permission in favour of The Shakti Plastic Industries for disposal of Refused Derived Fuel (RDF) from SLF Okhla on as is where is basis without any cost to South Delhi Municipal Corporation**

Madam/Sir,

Whereas, permission vide letter no. D-313/EE(SLF)/O/SDMC/2020-21 dated 02.03.2021 was granted to you by the Competent Authority for "*disposal of Refused Derived Fuel (RDF) from SLF Okhla on as is where is basis without any cost to South Delhi Municipal Corporation*" subject to the terms & conditions as elaborated in the aforesaid permission letter.

And whereas, you were required to submit your unconditional acceptance and enter into an agreement with SDMC within seven days of the receipt of aforesaid permission letter and also start the work within ten days.

And whereas, your representative visited the site at Okhla landfill in early March, 2021 and the available land required for processing of RDF/deploying of machinery/equipments was shown to them. The piece of land was subsequently leveled and marked by the SLF staff for your convenience.


And whereas, you have failed to take up the work at the site as per schedule despite several verbal reminders.

And whereas, a letter vide no. EE/SLF/O/SDMC/2021-22/76 dated 23.4.2021 was issued to you to take necessary steps for the setting up of their facility at the site and to submit your unconditional acceptance of the term and conditions & enter into an agreement with SDMC in this regard. You have stated vide reply dated 05.05.2021 that the delay is mainly due to epidemic situation and travel restrictions etc. However, the reasons submitted by you were not found satisfactory in view of the delay of about three months on your part.

And whereas, another letter vide no. EE/SLF/O/SDMC/2021-22/99 dated 24.5.2021 was issued to you as a final reminder to take immediate steps for setting up of your facility and start processing/disposal of the RDF at the Okhla dūmp site without any further delay and completion of required formalities with SDMC.

Now, therefore, the Competent Authority, considering the gravity of the matter and essence of time for setting up of your facility, has in exercise of its powers, vide orders dated 16.06.2021, directed that:-

1. The permission granted to the firm i.e. M/s The Shakti Plastic Industries vide letter no. D-313/EE(SLF)/O/SDMC/2020-21 dated 02.03.2021, is revoked with immediate effect.
2. The firm i.e. M/s The Shakti Plastic Industries is hereby blacklisted/debarred from participating in SDMC tenders/works for a period of one year from the date of issue of this order.
