NOTICE INVITING TENDER

1. Open online item rate / Percentage Rate as applicable tenders are invited from experienced and financially sound eligible Contractors / Firms / Companies for award of Works under single stage two-bid system (Technical & Financial Bid) are invited on behalf of Commissioner, S.D.M.C. Bidding Documents can be downloaded from the website <https://etenders.gov.in/eprocure/app> OR visit SDMC website www.mcdonline.nic.in/SDMCPortal/ Tenders/PPP-ETENDERS. The Technical bid will be received online as well as manual, However, the financial Bids will be received online only at e-tenders portal of SDMC.
2. The registered contractors of MCD (SDMC/NSDM/EDMC) are also eligible to tender for the amount they are registered subject to the condition that they fulfil eligibility requirement in Technical Bid submission. They will upload the valid registration certificates issued by any Municipal Corporation of Delhi i.e. SDMC/EDMC/NDMC along with "Performa for Earnest Money Deposited Declaration"
3. For other contractor (s)/New bidders for tendering/bidding in SDMC. 4. The Bidder should have sufficient financial turnover Average minimum 100% of Estimated Amount for the respective tender during the last three years. Copy of Financial Turnover Certificate, duly certified from a registered CA for the preceding three financial years, should be submitted.
5. **SELECTION PROCESS** A single stage, two-bid system process (Technical & Financial Bid) will be followed for selection of a suitable contractors for this work. All interested firms that qualify each of the following eligibility criteria may apply. Based on the Technical compliance as submitted by the eligible bidder, SDMC shall shortlist bidders for opening of financial proposal. Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The firm having lowest financial bid shall be considered for award of work.
6. Tender cost (Non refundable) as specified against each tender shall be made by way of Demand Draft/Bankers Cheque/ Pay order ONLY. The bid security (EMD) as applicable against each tender shall be paid by way of separate Demand Draft/Bankers Cheque/ Pay order only. The said performance security shall be deposited within 15 days of issue of Letter of Intent/Acceptance from SDMC. Failure in timely submission of required Performance Security the EMD deposited by contractor shall be forfeited to the SDMC and further necessary action for debarring / blacklisting of bidder may be initiated by S.D.M.C.

(iii) Copy of Valid PAN Registration. (iv)Valid GST Registration. (v) Experience in similar nature of work/s as applicable. (vi) Financial Turnover Certificate duly certified by Registered C.A. as applicable (vii) The Company/Firm profile Detail of the firm/bidder whether participating as Partnership Firm OR Proprietor-ship Firm OR Individual Firm OR Private Limited Firm or other. AND One Central Government Department / State Government Department/ Central Autonomous Body / Central Public Sector undertaking in India. The completion certificate of work(s) executed / completed, issued from competent authority be submitted along-with Technical Bids.
