**PUBLIC AUCTION NOTICE**

The unclaimed items/goods namely (i) vehicles (ii) Iron Scrap (iii) Wooden Scrap (iv) Plastic Scrap and other miscellaneous items, which were removed/confiscated by Licensing Department, Central Zone from the public/govt. land/footpaths etc. u/s 322 of DMC Act, 1957 **will be auctioned on 07.07.2022 at 11:00 AM** in the Municipal Store situated at near MC, Primary School, Amar Colony behind Police Station Amar Colony, Lajpat Nagar -IV, New Delhi.

Each bidder shall deposit the earnest money of Rs.2,50,000/- in the shape of DD/PO in advance i.e. on 06.07.2022 upto 04:00 PM in favour Commissioner, MCD, which shall be refunded/adjusted after the auction is over.

Each bidder shall have to provide self attested copies of PAN Card/Adhar Card/GST Registration details alongwith the payment of earnest money.


The highest bidder whose bid is accepted Auction Board, shall have to deposit the entire amount (after adjusting earnest money) in the shape of Demand Draft in favour Commissioner, MCD latest by 03 PM on 12/07/2022. If the 1<sup>st</sup>/highest bidders fails to pay the auction amount, the earnest money despitd by him/her shall be forfeited.

The earnest money of 2<sup>nd</sup> and 3<sup>rd</sup> highest bidder shall not be refunded till the bid amount deposited by the 1<sup>st</sup> highest bidder. In case the 1<sup>st</sup> higher bidder fails to deposit the amount, his/her earnest money shall be forfeited and the bid shall be offered to 2<sup>nd</sup> highest bidder and he/she shall have to deposite the 2<sup>nd</sup> highest bid amount offered by him or her. In case, he/ she also fails to deposit the bid amount, his/her earnest money shall be forfeited. After that bid will be offered to 3<sup>rd</sup> highest bidder for deposing the 3<sup>rd</sup> highest bid amount. In case, he/ she also fails to deposit the bid amount, forfeiting his earnest money, the auction shall be cancelled.

The Auction Board reserves the right to cancel any bid without any reason for the same. The successful bidder will have to remove the auctioned items/goods/vehicles from the store within 15 working days of date of auction failing which the MCD shall not have any responsibility for the auctioned goods. After 15 days the Department shall charge Rs.5000/- per day as storage charges from the successful bidder for not removing the goods within the stipulated period.

The vehicles/goods/items will be dismantled to scrap by the successful bidder. An affidavit in this regard, shall be submitted by the successful bidder before removing the goods from the Mpl. Stores.

The items/goods/vehicles can be inspected on any working during the office hours after obtaining permission from Administrative Officer, Central Zone. The items/goods will be auctioned on 'as is where is basis'.
