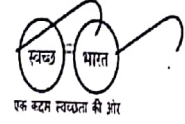

Note:-

- The security amount Rs. 15,000/- per booking and the sanitation charges Rs. 1500/- per day will also be applicable in aforesaid Community Halls as per previous practice.
- The AC facility in aforesaid Community Halls has been made optional. The booking parties who opts AC facility then only the charges of AC should be charged.
- In case, the booking parties opts the AC facility, they will have to arrange DG Set of 750 KVA capacity for the supply of electricity to the AC Units at their own cost. This should be printed on the G8 receipt.

The Director (IT) is requested to direct the concerned to revise the rates of the AC Community Halls on SDMC website.
