

## **Self Declaration/Undertaking**

### **SELF-DECLARATION/UNDERTAKING FROM THE APPLICANT OF VETERINARY TRADE LICENSE (Meat shop)**

I do hereby solemnly affirm and declare and also undertake to abide by the statements made herein below:-

- 1) That I agree that the veterinary trade licence is being issued in the name of the establishment and do not in any way carry any legal title, right or ownership. That I shall not claim any right/title in the property/ premises on the basis of the said veterinary trade licence.
- 2) That the building is structurally safe and sound. And in case of any accident/ mis-happening, I will be liable and completely indemnify/ keep harmless of NORTH DMC of any action that may be taken or proposed to be taken by any of the authority of Government Department or any Court of Law for any claim /damages or legal liabilities from any quarter. I shall maintain the structural stability during the continuation of trade.
- 3) That I further undertake that I shall not claim any regularization of unauthorised construction and ownership nor raise any other type of claim on the basis of the Veterinary Trade License being granted to us and the said building /shop is less than 15 Meter of height under regulation of MPD-2021.
- 4) That I will not held NORTH DMC responsible or liable for any action against me by authority, arising from or out of the grant of the said veterinary trade licence and completely indemnify/ keep harmless of NORTH DMC of any action that may be taken or proposed to be taken by any of the authority of Government Department or any Court of Law.
- 5) That there is no court case on account of violation of any law is pending against the above establishment with respect to grant of veterinary trade licence and I fully indemnify NORTH DMC for any loss due to court case or any reason whatsoever with regard to dispute being applied/sanctioned herewith.
- 6) That I further undertake that I shall install an active Fire extinguisher approved by Delhi Fire Services so as to safeguard the licensed premises from negligent acts which may cause fire or otherwise endanger public safety. I shall completely indemnify the NORTH DMC from any incident of fire due to the grant of the said license.
- 7) That the license if granted by the Commissioner, NORTH DMC for running the said Veterinary Trade License in the present premises, shall be liable to be suspended, revoked or cancelled at any time by the Commissioner or any other officer authorized by him as per provisions under section 430 (3) of the DMC Act.
- 8) That I undertake that the proposed activity is permitted activity as per provisions under Master Plan-2021 of Delhi and I have not applied for the veterinary trade which is prohibited by any Act/ Law/ Government Orders/Direction from any court of Law/ MPD-2021.
- 9) That I shall keep the license prominently displayed in my establishment at all times and on demand by any officer/representative of NORTH DMC shall produce the same for inspection at any time without any advance notice.
- 10) Imposing the mandatory condition to all the owners of Meat shop keeper to ensure segregation of waste at source as prescribed in the solid Waste Management Rules, 2016 facilitate collection of segregated waste in separate streams. Handover recyclable material to either the authorised waste pickers or the authorised recyclers.
- 11) That I undertake to ensure that no pollution will be caused by running the above said veterinary trade at the above said premises and in case at any stage, it comes to the notice of NORTH DMC or any Statutory Authority that the unit / establishment is causing pollution of any kind, I/we shall be liable for action under any provision of law.
- 12) That I undertake to ensure that there is no encroachment on public Land due to unit running Veterinary Trade. I understand that in case any encroachment on public land is found, punitive actions under DMC Act 1957 including revocation of license can be undertaken.
- 13) That I understand that the present license is granted without verification of the records of conversion charge, parking charge and property tax and I have paid all the applicable Municipal Charges, taxes, dues against the subject premises and further affirm to pay all taxes, charges, dues, levies, penalties etc payable to North DMC in future as well as per DMC Act 1957.
- 14) That at any point of time if any Law/Act/Govt. Order/Directions from any Court of Law/competent authority of North DMC/MPD-2021 prohibits any trade activities to be carried out, I/We shall abide by such law/act/Govt. order/Directions from any Court of Law/MPD-2021 and honour it.

15) That this license is issued purely on the basis of self-declaration/undertaking. If any of the statements of the self-

declaration/undertaking are subsequently found otherwise, the license is liable to be cancelled/ revoked for all intents and purposes forthwith while forfeiting the fee and I/we shall be liable for legal and penal action for obtaining license fraudulently by making false averments. The grant of license shall not amount to permission in any manner whatsoever, for change of land use of the premises in question.

16) That I will be responsible for maintaining the quality & standards of meat being sold & transported from my Meat shop and I will not cook the meat items or any other food items at my above Meat shop.

17) That I will abide by the changes/modifications/amendments, if made in future in Meat shop policy.
