# 1.1. About Veterinary Trade License (VTL)

Veterinary department deals with wide sphere of work such as Issuance of Licenses w.r.t Meat Shops, Meat processing units, Cattle Dairy and Registration of Platform allotted by DDA categories.

This document covers all the important details of the Veterinary Trade License Application like Application features, Interfaces, Functional and Non-Functional requirements, Forms and its logical validations

### 1.2. Purpose

The purpose of the VTL Online Application is: -

- Transformation of legacy process and afresh development of web application as per the current functional and technical requirements.
- Facilitate citizens with cashless, paperless, and faceless system.
- Advanced GUI of Online registration system can help the citizen to easily apply fresh license and renewal of license.
- Allows preservation of reporting forms in digital mode.
- Process oriented architecture which helps citizen to do easy registration for license without visiting MCD department from any internet point.


# 2. User Manual

### 2.1. Citizen Signup/Login

- MCD Website through  $https://mcdonline.nic.in \rightarrow click on$ *Online Services-> Veterinary* **License** and click on "Citizen Login"
- 2. If your Mobile number is registered, you can login directly.
- 3. If your mobile No. is not registered,



4. Registration page will open, fill mandatory details and then click on Submit button



- 5. You will be redirected to Citizen Login Page with message "Registered successfully. Now, login with Registered Mobile No:98xxxxxx66".
- 6. You can Login in the system through mobile OTP authentication.
- 7. Citizen can also change mobile number and other details through "Edit Profile" option available under name display at top right corner



- 8. On successful login, you will be redirected to Online Services Page.
- 9. Click on "Veterinary Trade License", your login account will be opened with previous details of Veterinary Trade registration if any.
- 10. Important instructions and Guidelines may also be read by the Citizen for self-help.
- 11. Policy regarding Meat Shop, Cattle Dairy, Meat Processing Unit may also be read to avoid any confusion.

#### 2.2. Citizen Dashboard

1. Dashboard provides listing of all Veterinary Trade registration records submitted by you alongwith key detail and status.



2. On the left side of page, you can avail options for "Apply for Newlicense" and "Search Legacy Record" after reading the Important Instructions and General Guidelines.



3. "Apply for New license" and "Search Legacy Record" option can also be availed through menu bar

4. You can access various services using Action buttonsuch as Apply for Amendment, Renewal and Surrender based on request status alongwith download Provisional License, download payment receipt and download Final License etc.



### 2.3. Search Legacy Record

- 1. Searching can be done using in Search Legacy data.
- License Number/Tr. No./ Reference No. Or
- Unit/Shop or Applicant Name.
- 2. After filling the mandatory details mentioned above (minimum 2 characters are required to search), click on the Submit button.
- 3. If the data is available in respect of the entered searching parameters, it will be reflected.
- 4. Click on the Action tab available against the concerned application and relevant options will appear like –Download license, Apply for Amendment, Renewal and Surrenderbased on License Validity and Request Status details.
- 5. You may select and proceed as per the requirements.

# 2.4. Apply for New License


Using following steps, you can register to obtain New License:

Application provides an option to apply for fresh and renewal of license for 1/2/3 years as per the requirement of Citizen.

- 1. Fill the New License Registration form correctly with all mandatory fields and click on Submit. It will not allow submission unless mandatory items are filled.
- 2. There are multiple sections available in the New License Registration form i.e., Trade Type Details, Applicant Details (Name, DOB, Address, Photograph etc.), Trade Details (Name, Year of Est. etc.), Address of Unit, Partner Details (if any), Trade specific details etc. and upload required documents.
- 3. First section covers Trade category and Nature of Trade. Nature of Trade is dependent on Trade Type. Trade type have values as Meat Shop, Cattle Dairy, Meat Processing Unit and Horse buggy. Trade type to be selected as per the requirement of License.



4. Further, second section covers about Application details such as Applicant Name, Date of birth, Father name, Mobile number, Email id, Residential Address and Photograph.



5. Next section covers information related of Establishment/ Unit/ Trade/ Platform allotted by DDA




6. Next sections cover important information about Address of Unit/ Dairy/ Platform – Allotted by DDA (Underuse in business).



7. Next sections cover information about type of constitution. In case of constitution type as Partner, all details of partner to be added.






11. Information related to **Platform allotted by DDA** (2.4.11) to be provided as per below important criteria's –



- 12. Last section is Document section where all mandatory and required documents need to upload. After uploading all mandatory documents and filling mandatory information, click the confirmation check box and click Submit button to save details and proceed for further Fee Payment. "Save as Draft" can be used to save filled information and submit later on using Edit option available under Action button in Dashboard.
- 13. On successful submission of the form, citizen will be redirected for Fee payment calculation page to re-verify the payment components and amount before proceeding to final payment. If all payment details are ok, then click on Submit button.



14. After verification, citizen will be redirected for payment and the fee, if applicable, can be paid using online payment gateway for debit/credit / Internet banking etc.



- of the respective MCD Official, you will be notified regarding approval or rejection via SMS and status of application will also be reflected on citizen dashboard. All the request will be assigned to Veterinary Trade Inspector at first level for verification.
- 16. While application is under progress, you can download Payment receipt from Action button available in citizen Dashboard.
- 17. If application is approved, license will be available for download to the citizen in the dashboard under the Action tab available against the submitted application along with options for Renewal, Amendment, and Surrender.



- 18. In case of request rejection by MCD Officials, Rejection letter with rejection reason can be viewed in Action tab.
- 19. Similarly, if any deficiency is raised by MCD Officials then click on deficiency submit and re-upload deficient documents for approval as per deficiency remarks given in deficiency letter.

Note: In case your payment has been deducted but payment receipt is not available then then use "Reconcile" option after 15 min.

### 2.5. Apply for Renewal

Note: Renewal can be applied on expiry of License.

1. If License is expired, Renewal option will be available to the citizen in the dashboard under the Action tab available against the approved application.



- 2. Renewal Form will open on selection of Renewal option with all the allowed fields in editable mode.
- 3. Fields allowed to edit in case of Meat Shop are Email id, Mobile number, Res. Address with pin code, Source of Water, Drainage System, Type of Occupancy etc.
- 4. Fields allowed to edit in case of Cattle Dairy are –Email id, Mobile number etc.
- 5. Upload required documents, click the declaration and Click Renewal License Button
- 6. On successful submission of the form, you will be redirected for Fee payment calculation page to re-verify the payment components and amount before proceeding to final payment. If all payment details are ok, then click on Submit button. (Similar to 3.4.9)
- 7. After verification, you will be redirected for payment and the fee, if applicable, can be paid using online payment gateway for debit/credit / Internet banking etc.
- 8. Once the payment process is completed, the application will be submitted for the approval of the respective MCD Official, you will be notified regarding approval orrejection via SMS.
- 9. While application is under progress, you can download Payment receipt from Action button available in citizen Dashboard
- 10. If application is approved, Renewal license will be available for download to the citizen in the dashboard under the Action tab available against the submitted application alongwith options for Amendment and Surrender.
- 11. In case of request rejection by MCD Officials, Rejection letter with rejection reason can be viewed in Action tab.
- 12. Similarly, if any deficiency is raised by MCD Officials then click on deficiency submit and re-upload deficient documents for approval.

# 2.6. Apply for Amendment

Note: Amendment can only be done if License is Valid.

Amendment can be apply in case of Death of owner only. Citizen can apply for amendment in following condition only-

- a. If License is valid and validity is more than 1 year, Amendment will be apply by the citizen in the dashboard under the Action tab available against the approved application.
- b. Citizen can apply for amendment within two months of Date of Death. Thereafter, system not allows citizen to apply for amendment.
- c. After Death of owner, If License expired within six months then legal heir use existing license till validity and apply for renewal in the name of existing owner then apply for amendment.
- 1. Amendment Form will open on selection of Amendment option with all the allowed fields in editable mode.



- 2. Fields allowed to Amend in case of Meat Shop/ Meat Processing Unit/ Registration of Platform allocated by DDA are Applicant Name, Father's Name, Date of Birth, Photograph of owner, Email id, Mobile number, Res. Address with pin code, Name of Unit/ Shop, Type of Occupancy, Type of Constitution etc.
- 3. Fields allowed to Amend in case of Cattle Dairy are Applicant Name, Father's Name, Email id, Mobile number, Res. Address with pin code, photograph, Name of Unit/Shop, Type of Occupancy, Date of Birth, Type of Constitution etc.
- 4. Upload required documents, click the declaration and Click Amendment License Button
- 5. On successful submission of the form, citizen will be redirected for Fee payment calculation page to re-verify the payment components and amount before proceeding to final payment. If all payment details are ok, then click on Submit button.
- 6. After verification, citizen will be redirected for payment and the fee, if applicable, can be paid using online payment gateway for debit/credit / Internet banking etc.
- 7. Once the payment process is completed, the application will be submitted for the approval of the respective MCD Official, you will be notified regarding approval or rejection via SMS.
- 8. While application is under progress, you can download Payment receipt from Action button available in citizen Dashboard
- 9. If application is approved, amended license will be available for download to the citizen in the dashboard under the Action tab available against the submitted application alongwith options for Renewal and Surrender.

- 10. In case of request rejection by MCD Officials, Rejection letter with rejection reason can be viewed in Action tab.
- 11. Similarly, if any deficiency is raised by MCD Officials then click on deficiency submit andre-upload deficient documents for approval.

# 2.7. Apply for Surrender

Note: Surrender can be applied on Valid License.

1. If License is valid, surrender option will be available to the citizen in the dashboard under the Action tab available against the approved application.



- 2. Surrender Form will open on selection of Surrender option.
- 3. To surrender the license, click the declaration and Submit Button.




- 4. On successful submission of the form, you will be redirected for Fee payment calculation page to re-verify the payment components and amount before proceeding to final payment. If all payment details are ok, then click on Submit button.
- 5. After verification, you will be redirected for payment and the fee, if applicable, can be paidusing online payment gateway for debit/credit / Internet banking etc.
- 6. Once the payment process is completed, the application will be submitted for the approval of the respective MCD Official, you will be notified regarding approval or rejection via SMS.
- 7. While application is under progress, you can download Payment receipt from Action button available in citizen Dashboard
- 8. If application is approved, surrender receipt will be available for download to the citizen in the dashboard under the Action tab available against the submitted application
- 9. In case of request rejection by MCD Officials, Rejection letter with rejection reason can be viewed in Action tab.

# 2.8. Submit Deficiency

 If any deficiency is raised by the concerned department, click on "View Deficiency" under Action.



2. Deficiency form will open, check for Deficiency remarks in deficiency letter where deficient documents will be mentioned.



3. Re-upload deficient documents and submit.

# 2.9. Check Rejection Remarks

1. If request is rejected, then check Rejection letter (Document received from inspection) to view rejection remarks.
